After that date, any remaining tables will be assigned on a first come, first served basis.

Payment, in full, is due by July 1, 2025 at 5:00 PM or the table may be forfeited and given to the next vendor in line. No refunds will be given in this case.

REGISTRATION INFORMATION

Applicants must meet eligibility requirements to display and sell arts & crafts at the event. Table fees are \$175 until May 31 and \$200 starting June 1st and will include 1 table and 2 chairs for the full 4-day event. There will be no partial leasing on a nightly basis; the applicant must pay for all four evenings of the event. Only 2 passes are included for each registered space, more may be purchased from the WEIO office or at the door.

WEIO or its representatives have the right to refuse any application whether or not a fee has been submitted; should an application be refused for any reason, a reason for refusal will be given to the registrant. Transferring the “ownership” of the table may be permitted from one applicant to another dependent upon the approval of the WEIO Table Committee Chair or their representative. Because of the limited space available, WEIO considers those applications received the earliest on a “first come, first served” basis. Due to WEIO's standing as a 501(c)3 non-profit, no religious or political stance can be promoted at our event.

Please Note: **The \$50.00 per table deposit is required** at time of application to reserve a space. If you would like to pay by credit card, please contact crystal@weio.org or call 907-699-6646. Payment in full, \$175.00 before May 31st or \$200 after June 1st, at the time of application, assures priority in table selection.

Due to potential venue constraints, WEIO reserves the right to make changes to this agreement at any time.

ELIGIBILITY REQUIREMENTS ~ LEASING POLICY

All artisans and crafts persons must comply with the Indian Arts and Crafts Act of 1990 (P.L. 101-644). You must be Alaska Native, Native American, Canadian Indian First Nations, Indigenous Siberian or Greenlandic, or of any Indian tribe of the Americas to be eligible to lease an arts and crafts table. Evidence of your eligibility **may** be asked of you by proof of any the following:

- BIA CDIB/CIB/Tribal Enrollment Card,
- Regional/Village Shareholder Identification Card, or
- Canadian Indian Status Card
- Other

I. For any and all articles being offered for sale, proof of authenticity must accompany the piece by one or a combination of any the following identification vehicles:

- A. A Certified Silver Hand tag identifying the article as made by an Alaskan Native;
- B. The engraved artist's name and village, if the article is ivory, bark, baleen, soapstone, or jade;
- C. The artist's signature on sketched, painted or beaded artwork;
- D. The artist's signature or initials on all silver, gold or metal articles;
- E. In accordance with the Indian Arts & Crafts Act of 1990, it shall be unlawful to display for sale or to sell any product that falsely suggests it is Indian produced, an Indian product, or the product of a particular Indian Tribe, or Indian arts and crafts association.

II. Alaska Native, American Indian, Canadian Indian, Indigenous Siberian or Greenlandic, or one of any tribe of the Indians of the Americas businesses, who are selling for Native artists must provide or have business cards, names and addresses of all artists whose works are being sold.

III. All arts and crafts tables are the responsibility of the individual who purchased them. That individual is responsible to maintain the table to ensure that only those articles referred to in this application will be sold at the table. They are also responsible for complying with all applicable state and local laws; and The Carlson Center policies.

IV. World Eskimo Indian Olympics and/or The Carlson Center cannot be held responsible for storage, theft of, or damage to, any articles being offered for sale or personal items stored at the booth.

V. Should the individual who leased the table **fail to have their display set up by the end of the first day of the games**, WEIO reserves the right to change that individual's table assignment to ensure the prime tables are full.

VI. **Cancellations** for any reason after June 3, 2025 will incur a \$50.00 fee. Any remaining deposit will be returned to the applicant.

IMPORTANT: You must check in with the Arts and Crafts Table Coordinator before setting up your table.

Artisans may begin setting up their table(s) at 10:00 am on Wednesday of the event via front door access.

***Tables must be set up by 5:30 pm each day of the event.**

I certify that to the best of my knowledge and belief the above conditions are met by myself and any person whose products are being sold at my table. I understand that I subject myself to disqualification from participation in this event if this statement is found to be false.
