**First-time WEIO athletes are required to provide proof of eligibility.**

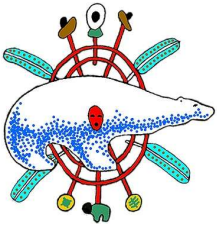
### MEDIA RELEASE

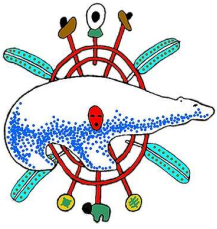
