LEASING POLICY

Eligible agencies or organizations applying for an **“Information Booth”** at the annual event of the World Eskimo-Indian Olympics must serve the purpose of providing a service available primarily, or with preference to those we serve, (Alaska Natives, Native American or other Indigenous People in the USA or circumpolar North). Booth spaces are the responsibility of the agency or organization applying. The contact person is responsible to maintain the booth to ensure that the booth is tended at all times. **Two (2) passes** are included for each booth registered. Additional passes can be purchased at a discounted rate (6 for \$50.00). The Organizing Committee of WEIO or its designated representatives reserve the right to refuse any application whether or not a fee has been submitted; should an application be refused for any reason, the application, leasing fee, and a reason for refusal will be given to the applicant. **If the applicant cancels before 6/30/2026 a 75% refund will be given; if the applicant cancels after that date a 50% refund will be given.** There will be no partial leasing on a nightly basis; each application submitted will be considered for the entire event, four (4) evenings. Transferring the “lease” may be permitted from one applicant to another dependent upon the approval of the Organizing Committee of the WEIO, or its designated representative. Because of the limited exhibit spaces available, WEIO considers applications on a “first come, first served” basis. WEIO reserves the right to make changes to this agreement at any time. Due to WEIO's standing as a 501(c)3 non-profit, no religious or particular political stance can be promoted at our event.

Table set up starts at 10 am, Wednesday July 15th, and must be complete by 5:30 pm that same day.

LIABILITY WAIVER

_____ **I agree to the following:** I agree to release all claims from injury or death and to protect World Eskimo-Indian Olympics, Inc. (WEIO) from any such claim which may be brought. I choose to participate in WEIO and understand there are known and unknown risks, dangers, and hazards that may result in serious personal injury, permanent disability, or death, including those arising from the negligence, gross negligence, or recklessness of organizers, volunteers, or fellow participants. I agree to indemnify and hold harmless WEIO and to pay all costs of defense if claims are brought by me or anyone else against the released parties related to personal injury to me. I enter into this agreement based on my own information and judgment. I understand that I have the right to consult an attorney before signing and that this waiver gives up important legal rights, including the right to sue. By submitting my application, I acknowledge that I have read, understand, and voluntarily agree to this waiver
